In 2013, 26 Backyard Composting (BYC) workshops, vermicomposting and composting presentations were made throughout the County utilizing Master Composter volunteer and County staff. 1,063 Master Composter volunteer hours were contributed to the program, 664 residents attended workshops, and 326 compost bins were sold at events and an additional 79 bins sold at the RCWMD main office. The Department participated in additional public education outreach by attending 38 community events with an estimated attendance of over 12,070 county residents. The RCWMD continues to use mulch for erosion control at active and inactive landfill sites.

AR 2013 - Program is continuing. Recycling collection services are still offered within the franchise agreements in most service areas of the County. 1,717 tons of paper, 6 tons of greenwaste and 547 tons of other material were collected from commercial sources. 392 tons of paper, 2 tons of metals, 2,099 tons of greenwaste, 30 tons of organics, 78 tons of white goods, 2,917 tons of construction, and 125 tons of other materials collected from industrial sources. The waste haulers sent a letter to businesses and multi-family complexes, with County input, informing them of the AB 341 Mandatory Commercial Recycling (MCR) regulations. RCWMD has updated our website, sent a press release through our County Executive Office and provided information on MCR regulation at community events. The total visits to the Department website has been 63,898, page views for public notices is 1,950, and page views for recycling and composting for business is 856. The Department had a link created on the County's business registration website to our Department's Mandatory Commercial Recycling webpage. In addition, the Department worked with the County's Building and Safety group to have a MCR message added to the electronic business license renewal notification. RCWMD has also hired an intern to help with Planning as well as MCR notification, he has been sending e-mails to businesses on our list that are subject to the regulations, but not recycling through a hauler. This has generated calls from businesses that are self-hauling their recyclables or once informed, have been able to contract with their waste hauler for recycling services. According to the waste haulers there are 4,998 total businesses within Riverside County and 1,623 that are subject to the MCR regulations.

Riverside County is also a recipient of Tire Enforcement and Tire Amnesty Grants which are administered by the Code Enforcement Department.
