Yes. In July and October, the residents in Wildomar and Menifee areas incorporated. Due to the Menifee incorporation, one of the County's green waste recyclers, BP John, is now located in the City of Menifee. In December of 2008, Synagro, a biosolids composting facility, officially closed. Biosolids from Eastern Municipal Water District (EMWD), which would have been transported to Synagro, were instead transported to the Otay Landfill (San Diego) for disposal in the years 2007 and 2008. EMWD is working with a contractor to transport the material for land application. However, the additional disposal tonnage from the EMWD on unincorporated Riverside County has impacted our Per Capita Disposed rate. The unincorporated area of Riverside County is taking this tonnage entirely when, the majority of EMWD Reclamation Facilities are located within city jurisdictions rather than the unincorporated portion of the County.

AR 2008 - Riverside County Waste Management Department (RCWMD) continues to provide public outreach materials to the public, attends numerous community events and provides a wide array of promotional materials. The RCWMD developed a comprehensive Recycling Guide made available to residents and businesses. The guide promotes grasscycling in the Source Reduction sections. Grasscycling methods continue to be taught at the Backyard Composting workshops. All County parks (hundreds of acres) are mowed using low deck grasscycling mowers and clippings are left on the turf. The RCWMD Planning Staff continues to recommend conditions of approval on development projects within the County that promote recycling of green waste and xeriscaping. County Land Use Ordinance 348 Article XIXf Water Efficient Landscaping (Ordinance 859) has been updated and continues to promote water efficient landscaping, requiring the use of mulch and compost in landscaping. The Ordinance was adopted on 12/19/2006 and became effective 1/8/2007. The California State Association of Counties Challenge Awards honored Riverside County with Honorable Mention for the Riverside County Water Efficient Landscape Program. The County developed and adopted a Water-Efficient Landscape Ordinance in collaboration with a Water Task Force to ensure that landscaping designs use plant materials that are not incongruous with the climate and require exorbitant amounts of water to sustain. This definitive policy action directs the way new development designs landscaping plans so as to reduce annual water use. The guide offers developers and landscapers methods and guidelines on water-efficient irrigation, designs and a list of attractive drought-tolerant plants. Riverside County has taken a lead conservation role in the state by launching the objectives of the ordinance well in advance of the State's Draft Model Water Efficient Landscape Ordinance and implemented them 14 months prior to the bill's release.

AR 2008 - RCWMD continues to promote this countywide program through its website, hotline, ads, brochures (at events and through direct mail to most County residents) and flyers distributed at community events in the County. In 2008, 22 Backyard Composting (BYC) workshops, vermicomposting and composting presentations were made throughout the County utilizing Master Composter volunteers and County staff. 838 Master Composter volunteer hours were contributed to the program. 709 residents attended workshops, and 406 compost bins were sold. In addition to the BYC workshops the RCWMD and master composters conducted a Composting/Vermicomposting presentation at the Eastern Municipal Water District. This is a presentation that attracts a large group and provides information to interested residents. The Recycling Guide addresses BYC and use of mulch. County Parks District contracts for plant trimming services and requires trimmings to be chipped and used for mulch on park grounds. County Flood Control uses mulch along the Santa Ana River for erosion control and as a weed preventive. The RCWMD used 3,469 tons of mulch for erosion control at active and inactive landfill sites. The RCWMD Planning staff continues to recommend conditions of approval on development projects within the County that promote the use of mulch and/or compost in development and maintenance of landscaped areas.

AR 2008 - The County continues to purchase a variety of recycled content office products in accordance with purchasing policies, and it is looking for additional recycled content products to purchase in place of virgin material products. Materials purchased by RCWMD for used tire recycling promotion, used oil recycling promotion, and beverage container recycling promotion were made from recycled content, in accordance with CIWMB and DOC grant requirements. Facilities Management continues to use environmentally friendly "green" chemicals, ergonomic tools and cutting-edge cleaning technology. The County handles the re-utilization of computer related assets through its Surplus/Salvage Office, a part of the Purchasing Department. Used computers and peripheral equipment are turned in to the Salvage office and the County makes every attempt to re-distribute working items to other County departments or County sponsored organizations, including school districts and non-profit agencies associated with the County. To date, this program has been highly successful. Non-serviceable assets are sent to auction with the proceeds returned to the County. On November 25, 2008, the Riverside County Board of Supervisors approved an amendment to the Board of Supervisors Policy D-2: Use and Purchase of Low or Zero Emissions County Vehicles. This policy requires that whenever practical the use of low or zero emissions vehicles to be the "first choice" of daily, monthly, or long term lease arrangements. Additionally, in order to improve air quality in Riverside County and to meet local and federal air quality regulations, this policy recommends departments/agencies/districts consider the purchase of low or zero emissions vehicles as the "first choice" for fleet vehicle purchases in lieu of gasoline or diesel powered vehicles.

The Recycling Guide is available in electronic format online. The California State Association of Counties Challenge Awards honored Riverside County with Honorable Mention for the Trash to Treasure: Helping Communities Help Themselves. This program is a demolition grant program to reduce physical blight in less affluent redevelopment neighborhoods by demolishing substandard structures, cleaning up properties, and remedying trash accumulation violations in coordination with County Code Enforcement. The funding covers up to \$75,000 per redevelopment project area parcel, with no out-of-pocket costs to the property owner. During the October 2008 budget talks, County Supervisor Stone met with the County Executive Office as well as the various Department heads to come up with ways to save money as well as resources, the Safeguard County of Riverside Against Preventable Expenses (SCRAPE) program was formed. SCRAPE looks specifically at utility savings and the frequency of services for County Departments as well as eliminating government waste. This item was approved by the Board of Supervisors at the February 3, 2009 hearing.

AR 2008 - Land application of Class B sewage sludge was prohibited per County Ordinance 812. On February 18, 2004, the Riverside County Board of Supervisors adopted Ordinance 830 which now regulates the land application of Class A sewage sludge for agricultural activities. Synagro Regional Composting Facility was the only sludge/biosolids composting facility located in the County. A Settlement Agreement reached by Synagro and the County in February 2004 previously required Synagro to cease operations by December 2008. Due to its wind down period, Synagro discontinued acceptance of biosolids in fall of 2008. This, and closure of Nursery Products Composting facility in San Bernardino County, has resulted in thousands of tons of biosolids being landfilled in San Diego County from Eastern Municipal Water District. Planned recycling of biosolids by Eastern Municipal Water District was to begin in January 2009 at Tule Ranch in Arizona.

AR 2008 - The RCWMD continued to collect tires for a fee at three landfills: Badlands, Lamb Canyon and Blythe. The tires are source-separated, and removed from the landfill to an acceptable disposal or recycling locations (522.00 tons of tires were collected at landfills). The County was awarded a Tire Amnesty Grant with events to be conducted by the Community Improvement Specialists within Code Enforcement. In 2008, eleven (11) events were held within Riverside County. Tires are also collected and subsequently recycled through Illegal Dumping Clean Up Program (IDCUP). The IDCUP tonnage is combined with landfill tire tonnage. Riverside County is also a recipient of a Tire Enforcement Grant which is administered by the Code Enforcement Department. To date, 50 Notices of Violation have been issued and more than 20 locations have come into compliance with state requirements. Five violators that failed to comply were referred to the State for further enforcement action. In addition to enforcement, education plays a vital part in the program. Several training sessions benefited the tire haulers in Riverside County, who were trained on the proper way of documenting and manifesting waste tires.

AR 2008 - The RCWMD HHW Program continued its partnership with the City of Lake Elsinore to operate its Permanent HHW Collection Facility (PHHWCF) for all County residents. The Pedley facility was the second PHHWCF to open in the County. This facility was closed September 2008 and replaced by the Agua Mansa PHHWCF. A PHHWCF in Palm Springs was designed and construction began during 2008. The Agua Mansa and Palm Springs PHHWCFs were built utilizing some grant funds awarded the RCWMD by CIWMB. Agua Mansa opened in October of 2008 and Palm Springs opened in July 2009. Along with the construction of these two new facilities, the grant also provided funding for the RCWMD to improve the Lake Elsinore site allowing for better throughput for residents and expansion of the site to collect e-waste. Collectively, these facilities served 5,248 participants and collected 356,721 lbs (178 tons) of waste in 2008. The facility details have been reported through the CIWMB Form 303. Two Permanent ABOPs continue to operate every Saturday except holiday weekends [47 open days, 4,067 participants were served, and 157,409 lbs (79 tons) of waste was collected in 2008]. With the opening of the Palm Springs PHHWCF, the Palm Springs ABOP will close. This new regional facility provides the Coachella Valley residents with an expanded service year round. In the past, the Department did not host any Temporary HHW events during the summer months. The California State Association of Counties Challenge Awards honored Riverside County with Honorable Mention for the Household Hazardous Waste Program Cost Savings Restructure. The RCWMD is establishing a network of regional Permanent Household Hazardous Waste Collection Facilities to ensure the proper collection and cost effective disposal of products such as paints, solvents, chemicals, electronic waste, etc. Previously, these products could be delivered by residents only during temporary collection events. Many residents expressed interest in the ability to dispose of such products at regular fixed sites instead of holding onto waste until a collection event was scheduled. The new permanent facilities increase convenience for residents, further ensuring the proper disposal of hazardous waste and helping to meet the requirements of the California Integrated Waste Management Board and the U.S. Environmental Protection Agency National Pollutant Discharge Elimination System (NPDES).
