III. DISCUSSION ITEMS

A. Staff Update

Ryan Ross reported:

Newsletter-

The first quarterly Newsletter was sent out last month. Newsletters typically will include a staff evaluation on landfill related community issues-aesthetics, traffic, mitigation measures and other landfill related items.

2018 Annual Report-

The report process is running about a month behind. Once Waste Resources receives the 2018 Draft report from WMI it will be reviewed, go before the ARC then back to the COC by summer 2019. David Harich stated that Waste Resources will receive the report within a week.

COC Elections-

COC Chairman and Vice Chairman elections will take place at the next COC meeting.

Coldwater Wash Damage-

Damage to the cold-water wash due to recent rain was reported. Amie Kinne reported that Dawson Canyon Road possibly qualifies for repair funds through FEMA. Amie is working with EMD. David Harich and meeting participants discussed road grading, road improvements and road damage.

B. El Sobrante Landfill Update

1. General Site Operations

David Harich reported:

Temescal Valley Bicentennial Cleanup-

WMI provided four roll off bins for waste and a front loader to pick up the materials that were collected.

Dawson Canyon Visual Impact -

The Pond 4 rip-rap channel was painted tan to blend in.

A picnic table was installed at the bus stop.

The chain link gate by Pond 4 was replaced by a ranch style gate.

A Dawson Canyon Community sign was installed.

Habitat improvements and bulky item removal took place.

Construction Activities-

The landfill is conducting a formal closure process above Phase 8. Hydro seeding will include an increase in poppy seeds.

Phase 12 is currently under construction and due to be completed by December 2019.

The maintenance facility is under construction and is projected to be completed by the first quarter of 2020.

Waste volume and tonnage limits were discussed by COC members and David Harich.

C. Special Waste Materials

1. Sewer grit, fire debris, flood debris, etc.

David Harich Reported:

Approximately 17,000 tons of fire and flood debris from the Holy Fire have been accepted at El Sobrante landfill. Only natural debris are accepted.

Sewer Grit is scaled and sent to a prepared area to immediately for disposal.

1. Flood Hazards

Robert Cullen discussed flood hazards as they relate Dawson Canyon and the El Sobrante landfill.

B. El Sobrante Landfill Update

1. General Site Operations

David Harich reported:

Phase 12 is under construction. Blasting the rough subgrade was completed in January 2019. The clay liner is due to be installed in late September or early October. Amie Kinne requested a tour of Phase 12.

Phase 13 construction is anticipated to begin towards the end of 2020. The maintenance facility is under construction and is projected to be completed in January 2020.

The odor control system on the south berm were almost doubled and the system was extended. Four additional gas collection wells were installed on the south part of the landfill. Sixteen gas wells will be installed in Phase 10.

The riprap channel on Temescal Canyon Road (near Dawson Canyon Road) was maintained and monitored by USA Waste but is now the responsibility of the property owner.

C. Local Mitigation Trust Fund

There are no updates on the Local Mitigation Trust Fund.

D. Dawson Canyon Area/Landfill - Address Assignment Process

COC members discussed address assignment issues in Dawson Canyon.

Hans Kernkamp stated that there will be a representative from TLMA at the next COC meeting to address questions.

I. CALL TO ORDER AND INTRODUCTIONS

The meeting was called to order at 10:01 a.m. by Chairperson Lee Wilson followed by the Pledge of Allegiance and self-introductions.

II. APPROVAL OF August 12, 2019 MEETING MINUTES

Paul Rodriguez motioned and Amie Kinne seconded the motion to approve the August 12, 2019 meeting minutes as written.

III. DISCUSSION ITEMS

A. Staff Update

Ryan Ross reported:

On October 31, 2019, the Administrative Review Committee (ARC) voted to move the 2018 Annual Report forward to the Board of Supervisors.

John Hildebrand from the TLMA Planning Department was appointed as the new ARC Board member. ARC Board member Alex Gann representing the Executive Office (EO) will be retiring in December 2019. A new appointee from the EO is expected in 2020.

Hans Kernkamp provided an update on the Moreno Valley Transfer Station Waste Delivery Agreement that is scheduled to expire in 2020. The next 20 year Moreno Valley Transfer Station Waste Delivery Agreement is scheduled to go before the County Board of Supervisors in December 2019.

B. El Sobrante Landfill Update

1. General Site Operations

David Harich reported:

Closure construction and hydro seeding activity on 20 acres of closed area is taking place.

Phase 12 construction is still underway. Oversized rocks in the clay liner will be removed by next week. The Water Board review is taking place. Amie Kinne, David Harich and meeting participants discussed rock removal and the clay liner installation process.

The new Maintenance Facility is almost completed and is due to open in December 2019.

Landfill storm water preparation is taking place in anticipation of the rainy season.

30 gas collection wells have been installed in the south part of the landfill to address gas migration issues. 30 plus wells will be installed in the beginning of 2020. David Harich, Greg Reyes and meeting participants discussed gas extraction and gas monitoring levels.

A construction and demolition (C&D) transfer reload recycling operation is planned at El Sobrante landfill. The operation will help eliminate vehicle trip miles. The ARC provided consent for the proposed operation in October. David Harich and meeting participants discussed recycled material and the monitoring process.

C. Local Mitigation Trust Fund

There are no updates on the Local Mitigation Trust Fund. There is still approximately \$77,000 in the fund.

Hans gave an overview of the purpose of the Local Mitigation Trust Fund. Meeting participants discussed possible future uses of the fund.

D. Dawson Canyon Area/Landfill - Address Assignment Process

Rick Lantis from Riverside County TLMA provided information on the TLMA address assignment process. Meeting participants discussed address assignment issues in Dawson Canyon.

Annual Monitoring Report (AMR):

COC members discussed updates, edits and clarifications for the AMR.

Conditions of Approval (CoA):

COC members discussed updates, edits and clarifications for the CoA report.

COC members discussed updates, edits and clarifications for the MMP report.

Paul Rodriguez motioned and Ruth Brissenden seconded the motion to accept the report, noting non-compliance with AQ-12, and substantial compliance with T-3. The motion passed 4-0.

Jannlee Watson expressed concern over Dawson Canyon Road, community cleanups, hydro seeding and C&D transfer trucks.

Ruth Brissenden, Greg Reyes, and meeting participants discussed possible impacts from the new greenwaste bins provided by USA Waste to Temescal Valley residents.
